

§ 1 - General

(1) The following terms and conditions (by now named "Terms and Conditions") shall govern the sale of goods by KOPAJOS, with registered office in Dilou 1 Agios Gerasimos, 84600, Mykonos, Greece, tax number 143437747 (by now named "we" or "us") and the buyer (by now named "you"). Any terms and conditions that you propose to amend or derogate are subject to our written consent. By placing a purchase order through our website www.kopajos.com, it is deemed that you have read, understood and agreed to our Terms and Conditions. If you are unhappy with any clause of our Terms and Conditions, please contact us before placing an order.

(2) We reserve the right to add, delete or amend these Terms and Conditions without prior written notice at any time, at our sole discretion.

§ 2 – Contract

(1) Orders are only possible via the "Kopajos" website (www.kopajos.com). As soon as you have filled in the electronic order form and confirmed your order with the "purchase" button, the contract between you and us is established in accordance with the present Terms and Condition without a separate fulfillment confirmation from us.

(2) The prices and conditions shown at the time you placed the order and confirmed with "purchase" shall apply (i.e. prices, shipment's cost etc).

(3) You acknowledge ordering the products for your private noncommercial use. Distributing the acquired products for a commercial purpose is prohibited. We will protect our trademark rights according to the applicable trademark rules. If you wish to place an order of a higher volume or for commercial distribution, please contact us for a specific individual order (mykonos@kopajos.com). In case of non-information, high volume orders or high rates of orders in short term, we reserve the right to refuse or cancel your order.

§ 3 – Color of Products

(2) Please note that while we have made any effort to accurately display the colors of products, the actual colors you see significantly depend on your monitor and may not be accurate. If you should have a problem, question or concern, please contact us immediately at mykonos@kopajos.com.

§ 4 – Prices and Payment

(1) The total price of your ordered items plus shipping fees (if provided) as displayed (in Euro) on the web page will be billed to your credit card.

(2) If the shipping address is located outside of the countries or regions listed by our system you will be charged the country's applicable import duty and sales tax (including VAT).

§ 6 – Your rights of Return

(1) We gladly accept returns for any reason within 14 days from the date when you have received the goods. Shipping charges are not reimbursed.

(2) We will control all returned products. All goods must be returned in perfect conditions without signs of usage. All the return's costs are up to the buyers. We will dismiss the returned product if:

- The product shows signs of visible use
- The product is damaged as a result of return transport

Likewise, no good will be taken back if it shows signs of damage or interference, such as

- Natural wear and tear
- Events out of our control e.g. natural disasters
- Signs of improper use
- Interference by the customer or a third person
- Extreme use or extreme influence by the customer

We reimburse your payment (duties, taxes and other expenses excluded). In case of return, you will be charged for all shipping charges. The refund of the sale price will be carried out in the same manner as the original payment was made. In case of pre-payment method to order, we would ask you to please include your banking details.

8 Privacy and Policy

We will not share your data with third parties. The only reason we have to give your data to third parties is for logistical reasons (i.e. shipping your bought products to your address). All data collected from our web site are used for internal purposes only, respecting the GDPR Directive (EU) 2016/97.

9 - Warranty

In case of not irrelevant defect of the products you have the warranty rights provided by consumers law. The legal warranty covers defects of conformity which becomes apparent within 24 months from the date of delivery of the purchased product that, although at that time the defect was not immediately detectable. For making claims you must notify to us the presence of the defect within 1 month since you have discovered it. Pursuant to the law, in case of applicability of the legal warranty, you will be entitled to recovery the goods through repair or replacement, or, if that is not possible, to a reduction of the purchase price or the resolution of the contract.

9 – Applicable Law

These Terms and Conditions are governed by and shall be interpreted under the laws of the Hellenic Republic/Ελληνική Δημοκρατία and it is expressly excluded the application of the UN Convention on the International Sale of Goods Contracts.
